Newman Theological College offers bursaries to new and continuing students enrolled in its programs and courses.

The Catholic Teacher Education Bursary Fund was established in 1998 by the Superintendents of East Central Alberta, Elk Island and St. Thomas School Divisions.

Eligibility: Applicants must be employed by one of the three sponsoring school districts on probationary or continuing contract and recommended by the principal of their school.

Value: Bursary covers 75% of the tuition cost of graduate level courses.

Bursary covers 100% of the tuition of Certificate in Catholic Studies courses.

Number of Bursaries: Multiple bursaries available.

- All applications must be accompanied by a letter of recommendation from their principal.
- Note: Incomplete or inaccurate applications will not be considered.
